Program: **Preparation of SAR Applications**

Jack Muggli was born in Harlingen, Texas in 1942 and completed High School and College after moving with his parents to Corpus Christi. He and his wife Jennie have five children. She is originally from Pasadena, Texas and has been a DAR and UDC Chapter Registrar for the last 25 years.

In 2016 Jack retired as President & CEO of Jiuli USA, Hi-Tech Metals after working 50 years in the Industrial Distribution Industry. Involved mainly with Engineering and Construction Companies he has traveled to 27 countries on six continents.

Jack and his wife now live on the small farm they purchased in 1980 near Weimar, Texas. Jack is currently serving as the Texas State Registrar for the Coastal Group and Chairman of the State Genealogy Committee. Jack began working on his Family Genealogy some 60 years ago, his interest sparked by elderly relatives and old family letters, papers and photographs. Through research trips to Switzerland Jack was able to trace his father's family back to the early 1400's. Introduction of Guests: President Rodney Weems introduced our guests:



Program: Bobby Gervais, City Attorney, City of Manvel Texas. Mr. Gervais Presented on the Battle of New Orleans, January 8, 1815 - 2 weeks after the peace treaty between the United States and Great Britain was signed officially ending what is known as "The War of 1812). While the British had an overall strategy, the detailed execution on all fronts was their final defeat. Two of the more significant efforts that failed included: (1) an 80-mile supply line over sea and swamp, making it hard to transport cannons to their desired locations. Their plan was to use the cannons from their ships; however, they failed to realize that the cannons were mounted on the smaller recoil wheels -- works really well on-board a ship, but were no match when it came to traversing and operating in the Louisiana mud. The second major flaw was to not determine the flow of the current of the "Mighty" Mississippi that day, resulting in the deployment of a significant strike force 1 ½ miles downriver from the intended point of battle. Also presented, was information on Jean LaFitte, who assisted Andrew Jackson in the defense of New Orleans by providing critical cannons, crews, powder, shot and supplies. However, LaFitte may have been hedging his bets by also helping the British navigate the bayous and streams from their standoff Naval Forces to gaining undetected access to the City itself.
